This is a report of the activities of the HRFA since the last general assembly which was held in July 2019. The COVID-19 pandemic, since its onset, has spread to all countries in the world. This has forced governments to enforce social and physical distancing measures, lockdowns of businesses, schools and all social life, which had been presumed to be a common place to curtail the spread of the disease. This has disrupted a lot of regular aspects of life including sports and physical activity. In that regard football, as a number one sport in the country, was the first sporting activity to be swiftly suspended by the Government on Friday 13th March 2020 through an announcement made on the National radio and thereafter communication was transmitted through the relevant structures. This was done to safeguard the health of the athletes and the people involved in the game.

The COVID-19 pandemic arrived at a moment where the leagues were at peak and most of the leagues had started the second round of matches in the log. The lockdown was effected early wherein the full impact of the COVID-19 in the country had not been realized as there were concerns over the suspension of football activities at that time hence there were reasons for hope. Since the communication to suspend football came from the government, the EFA Executive took it upon themselves to give direction on shepherding the football business in the country through a number of circulars which were in turn transmitted to all HRFA affiliates through the online platforms created in respective leagues.

National Unrest

It is worth reporting that the HRFA Office was not spared on during the period of the national unrest as it was broken into on the night of Tuesday 29th June 2021. Two computers were stolen and it was set on fire however a quick intervention of police saved the offices by extinguishing the fire .This was the first Tuesday after the EFA elective congress which was held on Sunday June 27th, 2021. The matter was reported to the Royal Eswatini Police Services and investigations were on going.


